## Purdue Latin & Ballroom Dance Team Membership Contract – Fall 2018

I, the undersigned, understand the membership requirements of the Purdue Latin & Ballroom Dance Team, hereafter referred to as "the Team" for the **2018 Fall Session**. As a Team Member, I agree to abide by the rules as outlined in the current, accepted constitution\* of the Team. I will respect the coaches and the officers, the authority granted by their positions, and all other dancers on the Team. I understand that professional, mature conduct is expected at all times, especially at any time when I am representing (or may be construed to be representing) the Team.

I acknowledge that disruptive behavior, clothing, or hygiene will not be tolerated at any Team event. Proper hygiene includes the use of deodorant with antiperspirant, regular showers, oral care, attire that is clean and appropriate to my body type and the activity, socks (for gentlemen), and appropriate undergarments for all Team events including lessons. I understand that the Team reserves the right to refuse or revoke my participation in Team events for failure to comply with these standards.

Dues for the team are **\$100.00** for returning and new members and are non-refundable. Dues cover all lessons, open practices, and workshops. Payment for dues is expected in full at the time of signing this contract by **cash or check** (payable to **Purdue Latin & Ballroom Dance Team**). Finally, some lessons will take place in the Purdue France A. Córdova Recreational Sports Center; facility admission fees for these lessons are the responsibility of the member.

Members are encouraged to attend all lessons and to compete in the Purdue Ballroom Classic and the Ohio Star Ball.

## Waiver, Release and Hold Harmless Agreement

In consideration of permission granted by Purdue University allowing me to participate in **Ballroom Dance**, which will occur from August 20<sup>th</sup>, 2018 through December 8<sup>th</sup>, 2018, which is sponsored by the **Purdue Latin & Ballroom Dance Team**, I (together with my parent or guardian, if I am under the age of eighteen or under a legal disability) represent, covenant and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, under or through me, as follows:

- I. I acknowledge that participating in the Activity involves certain risks (some of which I may not fully appreciate) and that injuries, death, property damage or other harm could occur to me or others. I accept and voluntarily incur all risks of any injuries, damages, or harm which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or in part by the negligence or other fault of Purdue University, the Trustees of Purdue University, and/or its or their departments, affiliates, employees, officers, agents or insurers ("Released Parties").
- II. I waive all claims against any of the Released Parties for any injuries, damages, losses or claims, whether known and unknown, which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. I release and forever discharge the Released Parties from all such claims.
- III. I agree to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties.
- IV. I have carefully read and reviewed this Waiver, Release and Hold Harmless Agreement. I understand it fully and I execute it voluntarily.
- V. I understand that the team reserves the right to eject any person(s) deemed unruly or unfit to stay within the activity.
